## BOVEY TRACEY TOWN COUNCIL

Report of the questions, reports and representations which took place during the adjournments of the Town Council on Monday  $26^{th}$  September 2011.

#### Reports and comments from members of the public:

Sgt Ian Stevens (Team Leader for the area) introduced his colleague, PC Laurence Wills, the Neighbourhood Beat Officer who will be working in the Bovey Tracey/Heathfield area alongside PCSO Paul Wilson. The Police Sector has been restructured and is now known as "Teignbridge West". It includes Bovey Tracey and Heathfield, Newton Abbot, Chudleigh and Ashburton.

He distributed copies of the list of recorded crime in the area for August 2011 and made the following comments:

- a) Although there had been 32 crimes recorded in the area, the level of crime in Bovey Tracey was very low compared to other parts of the country.
- b) There had been a spate of mindless vandalism in Heathfield and one instance of arson which was being investigated.
- c) There were a total of 8 reported incidents involving youth anti-social behaviour across the area, some taking place in the early hours of the morning. However the police were already interviewing a suspect.
- d) There had been several reports of motorcycles being driven in an antisocial manner mainly in Bovey Tracey.
- e) He warned Councillors to be particularly vigilant as there had been a series of opportunist thefts from garages and houses in Moretonhampstead despite improved security measures so extra patrols had been arranged.
- f) In response to a question, he stated that the Devon & Cornwall Constabulary had the support of an excellent team of Special Constables who were working from Newton Abbot and Teignmouth, providing extra help during the night shift when the pubs and clubs closed.

Cllr Bray thanked the Police Officers for attending and they left at 7.10pm.

## Rev Kevin Hooke reported that:

- a) A Youth Pastor, Robin Smith, has been appointed for three years.
- b) The Community Church which meets each Sunday in St Catherine's School is well supported.
- c) The Summer Holiday Club was a great success, with 29 children attending from Bovey Tracey School, 16 from Blackpool School and 6 from home.
- d) 300+ people had attended the service held in Ilsington by Christians Together in Bovey Tracey when the Bishop of Exeter preached. He thanked the Town Mayor for supporting the event.

County, District and Town Cllr Gribble made the following observations:

# As Devon County Cllr

- a) He had been involved in the development of the "Wray Valley Trail", its route and access etc.
- b) He was monitoring the effect of revised Library Opening Times.
- c) Due to the £40m shortfall this year, the County Council was faced with tough choices. There will be a series of meetings around the County to keep members of the public informed and he encouraged Councillors to attend.
- d) He had not received any requests for extra street lighting to be kept on all night, so the policy of turning street lights out throughout the County at night would be implemented this winter.
- e) He had received complaints of vehicles being used for advertising purposes parking along the Bovey Straight (A382) stating that it was difficult to resolve this problem.

As Teignbridge District Cllr he had been involved with issues relating to:

- f) The play areas in Heathfield, particularly the security of children in Big Park.
- g) Car Parks, Public Toilets and Sports Facilities in the area.

Representing the Town, Cllr Gribble submitted a list of 15 events and meetings which he had attended since June 2011.

District Cllr Mrs Klinkenberg reported that she had attended meetings regarding planning, appeals, the Wray Valley Trail through Lustleigh and the Bovey Tracey Masterplan Consultations.

Cllr Elphick had attended meetings regarding allotments, the Football Club, Heritage Society, Information Centre and Heathfield Community Centre (which was appealing for volunteers to serve on its committee).

Cllr Evans tendered his apologies for meetings taking place in October 2011 as he will be on holiday.

Cllr Arnold had attended a very informative meeting of Teignbridge Association of Local Councils (TALC).

Cllr Allen had attended the three Masterplan Consultations recently held and commented on the disappointing attendance.

In answer to a comment regarding the local Fire Station, Councillors were assured that there were no plans to close it.

- i) It would meet an identified local need.
- ii) It would sustain and enhance the vitality and viability of the town centre.
- iii) It would be consistent with the function of Bovey Tracey as a Local Centre as identified in Policy SDP 1.
- c) Need to establish if the covenant is still valid. This can only be obtained by seeking legal advice.

- d) To date Storegap Commercial Ltd, acting on behalf of Sainsbury's plc, had only made an enquiry.
- e) If the land is to be sold it would have to be advertised on the open market.
