Report of the questions, reports and representations which took place during the adjournments of the Town Council meeting held on Monday $20^{\rm th}$ January 2014.

Reports and comments from members of the public:

PCSO Paul Wilson gave his report (*copies circulated at the start of the meeting) stating that:

- a) 18 crimes had been recorded during the recent period.
- b) A further 47 other incidents were also reported in the area many of which were weather related.
- c) 5 incidents of anti social behaviour had been recorded including one which related to youth anti social behaviour.
- d) During December Neighbourhood teams and Traffic Officers stopped 140 drivers who were committing motoring offences which included speeding, not wearing seat belts and lighting defects.

Rev. Kevin Hooke:

- a) On behalf of Rev. G Hamilton thanked the Town Council for the arrangements undertaken for the Carol Service.
- b) Noted that attendance at the "Messy Church" held at the Heathfield Community Centre is growing.
- c) Advised that Fr. G Stanton is now the incumbent at St. John's Church.
- d) Reported that St. Catherine's School, Heathfield has established a "peace garden".
- e) On behalf of Bovey Community Care Trust extended thanks to the Town Council for its financial support and noted that the Coat of Arms is now on the Trust's stationery.
- Mr P Beecher extended his appreciation to the Town Council for looking after the Town and for progressing the skate park project. He requested further clarification on matters relating to The Old Thatched Inn.

Mrs K King stated her support for the Town Council on the development of The Old Thatched Inn site but considered funding could be established in an alternative way.

Mr J Williams stated his support for the provision of a skate park and his concern regarding the proposed development of The Old Thatched Inn site in relation to possible flooding.

Cllr Allen opened the meeting and introduced Ms Jenny Handford, Ms Kate Freeman and Ms Tracey Scranage of the Friends of Sure Start (FOSS) at Moors Edge Children's Centre based at St Catherine's Primary School, Heathfield. Ms Handford and Ms Freeman gave a presentation outlining the formation of FOSS and the services and facilities the Centre offers to families with children under 5 years of age living in Heathfield and the surrounding area. They explained that FOSS would like to provide an outside play area at the Centre which is estimated to cost in excess of £7500.00 and they are currently seeking financial assistance. An invitation will be extended to Councillors to visit the Centre.

Cllr Allen thanked Ms Handford, Ms Freeman and Ms Scranage for the presentation and they left the Council Chamber at 7.25pm.

Mr Nance had a similar project to erect a concrete mermaid at The Point in Teignmouth which was refused by TDC on 4.7.13. (Planning Application: 13/00852/FUL and a subsequent Appeal, ref. APP/P133/A/13/2204088, dismissed on 17.1.14).

A letter, received from a parishioner, objecting to the proposal was noted.

Resolved:

To decline the request.

One member of the public left the Council Chamber at 7.35pm.

RP&P.14/08 Rendells Meadow:

Ref. min. no. RP&P.13/06. It was noted that Mrs M Manley of Tarn Hows, Bradley Road has contacted Cllr Allen directly in relation to the trees adjacent to her hedge situated in Rendells Meadow. Mrs Manley is requesting the clearance of some of the growth which she considers is affecting the health of the boundary hedge. Some remedial work has been undertaken. The Town Clerk inspected the site on 4.2.14 and confirms that there are no branches overhanging Mrs Manley's hedge and the trees do not appear to be affecting the health of the hedge.

Consideration was given to undertaking further remedial work to fully clear the branches of the trees along with the vegetation to a height of 1.5 metres. This will expose the hedge to full light and maintain the trees for the benefit of the residents and users of Rendells Meadow. Following discussion it was

Resolved:

To undertake the remedial work as set out above.

The cost for the work will be reclaimed from the Rural Aid grant for this project. Following discussion it was



Following the recent setting of Devon County Council's budget, Cllr Gribble updated Members on the future provision of youth services by DYS for Heathfield. He explained that communities were being encouraged to arrange their own youth provision on a voluntary basis. He noted that a consultation is currently taking place and a decision regarding the future provision will be made at the end of the consultation period. Cllr Kelly indicated that he hoped to attend the consultation meeting in Newton Abbot on 17 March 2014.

FR&GP.14/27 Electors' Fund:

a) Hennock Parish Council (HPC) is working on a project with Devon Wildlife Trust (DWT) to develop the area known as Black Path (Public Right of Way Path No. 18 which leads from Chudleigh Knighton play area parallel to the B3344) to form a circular link around Chudleigh Knighton Heath (*outline plan previously circulated) to include interpretation boards. Part of the trail is within the parish of Bovey Tracey. HPC has sourced most of the funding for this project and is now looking to submit an application to TDC's Electors' Fund.
b) Kingsteignton Town Council has requested support (*copy of email circulated at meeting) for funding towards the installation of sport equipment.

Resolved:
